Election 2018

During the October regular meeting of the Board of Directors, a Nominating Committee will be appointed to nominate at least one member for each of the three two-year term vacancies that will become available on the Board next June. Nominations must be received no later than December 8, 2017. The slate of nominations for the vacant positions will be announced in the 2018 Winter PostScripts.

Nominations

Eligible members interested in serving as a U. S. Postal Service Federal Credit Union director may call Betty Myers at (800) 877-7328, x1316 to request a Nominee Application Package with instructions for consideration by the Nominating Committee. Members may also be nominated by a petition submitted to the Secretary and signed by one percent (226 members) of the Credit Union's membership, along with a statement of qualifications, biographical data, and a signed certificate stating you are agreeable to the nomination and will serve if elected to office. In the event there are more nominees than vacancies, an election will be conducted by ballot. The results of the election will be announced at the USPS FCU Annual Meeting in the summer of 2018.

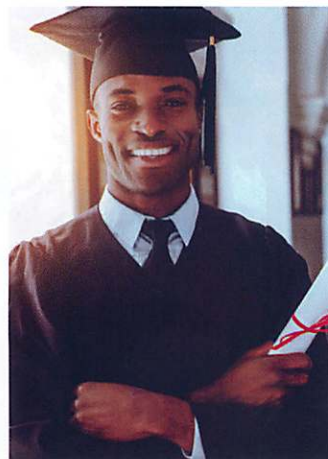
